**NON-PUBLIC SCHOOLS TRANSPORTATION REQUEST FORM
2020-2021 SCHOOL YEAR**

Residents of the Huntington Union Free School District requesting transportation for their children attending non-public schools must submit a request **on or before April 1, 2020** in order to be eligible for this transportation during the 2020-2021 school year. Late requests cannot be honored. *Requests for changes in transportation that lead to any additional cost to the district will **NOT** be honored after April 1, 2020 even if related to a change in schools.*

FOUR items showing proof of district residency should be submitted to the District Registration Office for all new registrants and for those who may be changing from a public to a private school.

An original birth certificate must be presented for all incoming kindergarten students. (Please do not mail birth certificates.) Children entering kindergarten must be five (5) years of age on or before December 1, 2020.

The Registration Office is located in the administrative wing of the Jack Abrams STEM Magnet School, 50 Tower St. Huntington Station, NY 11746. Registration Office hours are as follows:

- Mondays, Tuesdays, Thursdays and Fridays: 9:30-11:30 AM
- Wednesdays: 2:30-5:00 PM

Current district transportation eligibility limits are as follows:

- Kindergarten through grade 3: all students eligible
- Grades 4-6: students residing a 1/2 mile or further from the school
- Grades 7-12: students residing 1 mile or further from the school
- Maximum transport distance to any school: **15 miles**

We strongly recommend that if you are filing after March 13, 2020, you should either hand deliver or return the form by certified mail. Transportation Office hours are Monday through Friday 8:00 AM - 4:00 PM. **Original birth certificates are requested for all kindergarten students.**

Detach Part I and return Parts II and III to the District Transportation Office. Upon receipt, Part III will be stamped, dated and returned to you by mail. If you have not received Part III by March 20, 2020 we suggest that you call the Transportation Office to verify that your request has been processed. **A request form must be submitted for each student who will attend a non-public school during the 2020-2021 school year.**
