Steve Davis

Steve Davis has been involved in the Huntington community for over four decades. Whether you know him as a coach, a teacher, or a Special Olympics volunteer and devotee, Steve Davis has served our community in a number of different ways and has taught at every school in our district.

Mr. Davis graduated from Hicksville High School in 1968 where he played on the school's football and baseball teams. After graduating, Steve continued his studies at Cortland State, where he followed his passion of teaching and majored in physical education. During his four years, Steve was an active member of the Cortland community, playing on the school's football and lacrosse teams and also serving as Vice President of the student's section of the New York State Physical Education and Recreation Association. It was here that his passion for teaching was set in motion.

Upon graduating from Cortland, his teaching and coaching career began. Steve was hired to be the freshman assistant football coach at Toaz Junior High School and as a physical education teacher at Finley. At Finley, he also served as the school's head football coach for six years as well as the JV lacrosse coach at Huntington High School.

Then, just six years into his young career, Steve was named the head varsity lacrosse coach at Huntington High School – where he was very successful for eleven years. Then he decided to retire from coaching. Looking back on his career today, Steve is extremely proud of the fact that during his tenure as coach, he made it his personal responsibility to ensure that every one of his players got the opportunity to play college lacrosse, if they wished to do so.

During his 32-year teaching career, from 1973 to 2005, Steve taught physical education at every level in our district. And he didn't stop there – he ran the intramural sports programs at both Finley and the high school. Throughout the years, Steve's commitment to our kids and to our community has been undeniable.

In 2005, after hanging up his whistle, Steve got involved with the Long Island Chapter of Special Olympics. In 2011 and 2012, Mr. Davis served as the lead coordinator of Huntington High School's own Special Olympics Spring Games. The Special Olympics have become, and continue to be, a very important part of his life.

Linda Roth

Linda Costello-Roth has been a proud member of our Huntington community for as long as she can remember. Born in Brooklyn, she moved to Huntington at a young age in 1970, and came up through the Huntington school system. During her years of schooling, she attended Village Green School, Huntington Elementary (currently Jack Abrams STEM), Woodhull, Finley Middle School, and Huntington High School, she graduated in 1982.

Beginning at a young age, Linda was an incredible athlete. At Finley, she played volleyball, basketball, softball, and starred on the soccer team (the boys' team, nonetheless). At the high school, she played for the school's field hockey, volleyball, and basketball teams. In her senior year, Linda served as the captain of Huntington High School's first ever girls' soccer team, a program that has thrived ever since.

After graduating from Huntington, Linda went on to Hartwick College in Oneonta, New York, where she graduated with a degree in Business Management. From there, she earned a Master's degree in Special Education from C.W. Post. It was here that she realized her passion for working with children, particularly those with special needs.

In 1992, Linda began teaching at Finley Middle School and in 2003, she received her school Administration certification. With her strong commitment to Huntington athletics, she has coached lacrosse, both girls and boys soccer, tennis, and volleyball. In addition, she has coached field hockey and lacrosse at the high school.

In following her passion to serve children with special needs, Linda has become very involved in developing the Special Olympics program at Huntington High School, where she currently coaches floor hockey, track and field, and snowshoeing. The past two winters, the Huntington snowshoeing team has made particularly strong showings at the New York State Games. As the Special Olympics program continues to grow within our district, Linda will undoubtedly play a major role in its success.

Linda is the chairperson of the Special Education department, her next goal is to bring a Unified Sports program to Huntington. Unified is a fast-growing initiative that brings people with and without intellectual disabilities together on the same team to compete side-by-side. Overall, our community owes a great deal to Ms. Linda Costello-Roth.

Our Mission

The primary focus of the Booster Club is to financially enhance the district's physical education and athletic department budget in support of all sports. The goals of the Booster Club are to provide financial support to maintain and improve athletic facilities at our schools, to purchase equipment for our students and teams, to conduct summer sports camps, to distribute annual scholarships and to provide refreshments at athletic events and sports awards nights. We will do this through annual membership dues and other fundraising throughout the course of the year. To accomplish our goals, we ask that all families, particularly those with student athletes at Finley Middle School and the Huntington High School, coaches and school administration support the athletic programs in the district by becoming a member of the Huntington Booster Club and by participating in our fundraising events.

What We Have Accomplished

Over the past eight years the Huntington Booster Club has raised over \$325,000. This money has been used to enhance Huntington's athletic programs and facilities. Our first major project was refurbishing the cardio and weight room in the high school. We have added dugouts, a basketball shooting machine, golf bags, a home run fence for the girl's softball team, and a track high jump pit. In addition, we replaced the bleachers at Finley Middle School and annually award "Sportsmanship Scholarships" to graduating seniors. Thanks to your support, we have supported every athletic team at Finley and Huntington High School, with over 100 individual grants.
