The survey was conducted between March 4, 2015 and March 19, 2015.


A total of 531 out of 4,292 school board members responded to the survey – a rate of 12.4 percent.

The 531 respondents came from 362 different boards of education.


Nearly two-thirds of the 362 districts had one response. Here is a more detailed breakdown:
