

**HUNTINGTON UNION FREE SCHOOL DISTRICT
ANNUAL BUDGET VOTE AND ELECTION
MAY 15, 2007**

A Special District Election of the Huntington Union Free School District of the Town of Huntington, County of Suffolk, was held at Huntington High School, Oakwood and McKay Roads, Huntington, New York on May 15, 2007.

At 6:00 a.m. Daylight Savings Time, Mrs. Bender, District Clerk, of the Huntington Union Free School District, announced that the polls were open and would remain open until 9:00 p.m.

At 9:00 p.m. Mrs. Bender announced that the polls were closed and that anyone in line would have the right to vote.

A canvas of the voting machines by the District Clerk showed the following results:

PROPOSITION #I (BUDGET)

“RESOLVED, that the Board of Education of the Huntington Union Free District, Town of Huntington, County of Suffolk, New York, be authorized to expend \$99,199,355, the amount set forth in the proposed budget and to accumulate the balance proposed in the said budget during the school year beginning July 1, 2007, and to levy the necessary tax therefore..”

VOTE: **YES** 1556* **NO** 916

RESOLUTION adopted.

PROPOSITION #II (CAPITAL RESERVE FUND)

“RESOLVED, that the Board of Education be authorized to expend from the Capital Reserve Fund, established by the voters of the school district at the annual district election held June 3, 2003, an amount not to exceed \$1,500,000 for: at Huntington High School, renovation of the parking lot and sidewalks, \$620,000; at Finley Middle School, replacement of a fuel tank, \$125,000; at Woodhull Intermediate School, replacement of ceilings, \$300,000, and replacement of the public address system \$26,000; at Flower Hill Primary, renovation of the sidewalks, \$135,000, and security lighting, \$22,000; at Southdown Primary School, replacement of a fuel tank, \$125,000; at Washington Primary School, replacement of a fuel tank, \$125,000, and replacement of stage wiring, \$22,000.”

VOTE: **YES** 1720* **NO** 714

RESOLUTION adopted.

PROPOSITION III (EXCEL AID)

“RESOLVED, a) that the Board of Education of the Huntington Union Free School District, in the County of Suffolk, New York (the “District”), is hereby authorized to construct improvements to all District school buildings and to expend therefore an amount not to exceed \$1,357,070; (b) that a tax is hereby voted in the aggregate amount of not to exceed \$1,359,070 to finance such costs, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; (c) that the District has been allotted and expects to receive EXCEL (“Expanding our Children’s Education and Learning”) aid in a sufficient amount to fund said estimated total cost of not to exceed \$1,359,070 and the amount of taxes herein authorized to be levied will be reduced by the amount of an EXCEL aid so received by the District; and (d) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$1,359,070 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.”

VOTE: **YES** 1619* **NO** 787
