Dear Parents:

The Suffolk County Police Department has just notified the School District that a high risk (level 3) sex offender is residing within our District boundaries. In accordance with N.Y.S. Correction Law, Article 6C, Sex Offender Registration Act, I am notifying all parents of youngsters attending the Huntington Public Schools or living in the Huntington School District and attending private or parochial schools. As a School District, we are permitted by law to provide certain information about this offender. A copy of the information that the Suffolk County Police Department has provided regarding this level 3 offender is enclosed with this communication. The Suffolk County Police Department has also notified the District that low risk (level 1) and/or moderate risk (level 2) sex offenders are residing in the Huntington area.

All of our schools have procedures in place to ensure the safety of all students. Our building administrators are aware of the current situation. To enhance the precautions that we are taking as a school district, it is important that parents reinforce basic safety guidelines with their children. Please keep this in the proper perspective for your children by reassuring them that we do have a safe community, but that they need to be alert and careful.

Please also be aware that according to New York State Law, "it is illegal to use this information to commit a crime against the above listed person or to engage in illegal discrimination or harassment against this person." El departamento de la policía del Condado de Suffolk ha notificado el distrito escolar que un delincuente del sexo de alto riesgo del tercer nivel está residiendo de nuestra fronteras del distrito escolar. De acuerdo con N.Y.S. Correction Law, artículo 6C, acto del registro del delincuente del sexo, estoy notificando a todos los padres de los jóvenes que atienden a las escuelas públicas o residen en Huntington en el área del distrito escolares de Huntington y que atienden a escuelas privadas o parroquiales de este urbanización. Como el distrito escolar, nosotros somos permitidos por la ley propocione cierta información sobre este ofensor. Una copia de la información que la policía del Condado de Suffolk ha proporcionado con respecto a este plano 3 ofensor es encerrada con esta comunicación. La policía del Condado de Suffolk también ha notificado el distrito escolar que un riesgo bajo (nivel 1) y/o moderado riesgo (nivel 2) delincuentes sexual residen en la area de Huntington.

Realizar las precauciones que estamos tomando como el distrito escolar, es importante que los padres refuerzan puntas básicas de seguridad con sus niños. Mantenga por favor esto la perspectiva apropiada para sus niños tranquilizándolos que tenemos una comunidad segura, pero que necesitan tener alertas y cuidados.
