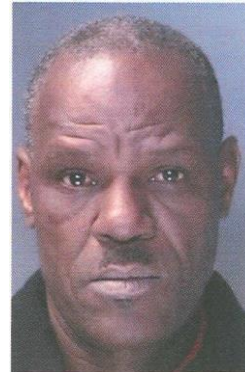


Offender Details
