REGULAR MEETING HUNTINGTON UNION FREE SCHOOL DISTRICT BOARD OF EDUCATION December 4, 2006

The Regular Meeting of the Board of Education of the Huntington Union Free School District was held on Monday, December 4, 2006, at Finley Middle School, Greenlawn Road, Huntington, New York. Mr. Lee called the meeting to order at 6:30 p.m.

ROLL CALL

There were present Board of Education Members Black, Collyer, Lee, Marchi, McGrath, Rogan; Superintendent Finello, Messrs. Giani, Grackin, O'Brien and Mrs. Bender. Mr. Forte was absent.

EXECUTIVE SESSION

A MOTION was made by Mrs. Marchi and seconded by Mrs. Collyer to go into Executive Session to discuss legal and personnel matters.

At 6:30 p.m. the Board of Education went into Executive Session.

At 7:45 p.m. Mr. Lee reconvened the meeting.

EMERGENCY EVACUATION PROCEDURE

Mr. Lee discussed the exits to be used in the event of any emergency.

SMOKE FREE SCHOOL DISTRICT

Mr. Lee announced that the Huntington Union Free School District is a smoke-free district and smoking is prohibited in all buildings and on school grounds.

COMMUNICATIONS AND ANNOUNCEMENTS

Mr. Lee thanked the Finley Middle School PTA for a wonderful reception and "Taste of Finley."

Mr. Finello invited all to the Holiday Wrestling Tournament on Saturday December 9, 2006 at Huntington High School. The high school gymnasium will be dedicated at that time as the Louis D. Giani Gymnasium.

Mr. Finello reminded everyone that there have been adjustments made to the school calendar with regard to winter concerts at the high school. Parents have been notified and the changes are on the district website.

Mrs. Collyer reminded everyone about the Western Suffolk BOCES referendum on December 14^{th} from 2:00-8:00 p.m. at James E. Allen. If the referendum passes, it would cost the Huntington School District approximately \$150,000 over a three-year period.

PUBLIC COMMENTARY

At that portion of the meeting set aside for questions and comments from the public a parent asked why the district does not have a "no nit" policy. Discussion followed. Mr. Finello will follow up.

Several parents of dual language children have concerns about the program for next year particularly if their children are moved to another building.

A parent asked why the public wasn't informed about the BOCES Referendum. Mr. Lee explained that it was in the local papers and on the district website.

A parent was concerned about the overcrowding in the elementary schools and the potential rezoning. Extensive discussion regarding the ELFACS committee followed.
