REGULAR MEETING HUNTINGTON UNION FREE SCHOOL DISTRICT BOARD OF EDUCATION AUGUST 20, 2007

The Regular Meeting of the Board of Education of the Huntington Union Free School District was held on Monday, August 20, 2007, at Huntington Intermediate School, Lowndes Avenue, Huntington Station, New York 11746. Mr. McGrath called the meeting to order at 6:00 p.m.
