

**REGULAR MEETING  
MINUTES OF THE BOARD OF EDUCATION  
HUNTINGTON U.F.S.D.**

**January 25, 2010**

The Regular Meeting of the Board of Education of the Huntington Union Free School District was held on Monday, January 25, 2010 at Jack Abrams Intermediate School, Lowndes Avenue, Huntington Station, New York. The meeting was called to order at 6:00 p.m.

**ROLL CALL**

**EXECUTIVE SESSION**

A MOTION was made by Mrs. Bené and seconded by Mrs. Rogan to go into Executive Session to discuss a legal and contractual matter.

**COMMUNICATIONS & ANNOUNCEMENTS**

Mrs. Paterson's to Visit Finley Middle School

Mr. Dwyer asked Dr. Card to explain the purpose of the scheduled visit on January 26, 2010 of the First Lady of the State of New York, Michelle Paterson to Finley Middle School. Dr. Card explained that Mrs. Paterson's visit was to address students to persuade them to participate in the program *Healthy Steps to Albany Challenge*.

Mrs. Rogan's NYSSBA Citation

Mr. Dwyer announced that Mrs. Rogan received a citation from the New York State School Board's Association because of the many programs and workshops she has participated in and the number of credits she has accumulated.

Huntington Foundation for Excellence in Education (HFEE)

Mr. Dwyer announced the HFEE fundraising event honoring Superintendent Finello took place on January 22, 2010. Mr. Dwyer thanked HFEE for all the money it raises for the school district and indicated how the grants received through HFEE have funded many innovative aspects of education in our district.

Trustees' Tour of 300 Nassau Road (formerly Toaz Junior High School)

Mr. Dwyer indicated that a contingent from the school district, including board members and central administration staff, along with our architects and lawyers, toured 300 Nassau Road several times from January 12<sup>th</sup> through January 15<sup>th</sup>. Mr. Dwyer invited the board members who were there to share their impressions. Mr. McGrath, Mrs. Rogan and Mrs. Bené commented and were all very favorably impressed with the condition of building. Discussion followed. The architects, Burton Behrendt and Smith, would be giving a report during this board meeting.

Several board members attended various events that took place in January throughout the district.

Mrs. Rogan attended the Pride Awards this month. These awards recognize student achievement for various reasons and are presented each month in different areas of study. Mrs. Bené and Mrs. Rogan were invited to read to the students at Southdown Primary School for the Parents as Reading Partners (PARP) Program. Mrs. Rogan thanked Mrs. Marino, Principal of Southdown Primary School, and Mrs. Weir, Reading teacher, for making the event such a success. Mrs. Bené thanked the PTA for introducing it to our schools. Mrs. Rogan also attended the Math Honor Society Induction and explained how the members of the Math Honor Society then tutor and help other students. She indicated it is a privilege as a board member to attend such events. Mr. Dwyer attended the National History Day Competition and the Science Trilogy Night. The students have fun while learning and the projects are very impressive. He thanked Mr. Leavy, Director of Humanities, and Dave Casamento, Director of Science for pushing to bring these events to the district. Mrs. Rogan commented about the Science Olympiad that took place on June 21, 2010 and noted that it was open to more students. Mr. Casamento announced that one of our students is an Intel semi-finalist this year.

## **PUBLIC COMMENTARY**

At the portion of the meeting set aside for public commentary the following comments were made:

Mr. Boyle, President of the United Public Service Employees Union (UPSEU) read a statement on behalf of six employee units without a contract.

## **ITEMS FOR DISCUSSION/ACTION**

### Academic Progress

Dr. Card introduced Georgia McCarthy, Director of Health, Physical Education and Athletics, who presented a very extensive report on the progress of students in the Physical Education Program and Athletics. She answered questions asked by the Board. Mrs. McCarthy thanked the Booster Club and the community for their support.

### Facilities Planning – Roger Smith, BBS Architects

Mr. Finello introduced Roger Smith of Burton Behrendt Smith, our architects, who at the request of the Board of Education visited 300 Nassau Road in order to evaluate the condition of the building and how it would suit our spatial needs. Mr. Smith gave a very detailed presentation on the facility and the changes that could be made in order for it to be used again as an elementary school. Cost was discussed as well as state aid and many other aspects of the project. Discussion followed.

### 2010-2011 State Aid Update

Mr. Finello indicated that on January 19, 2010 Governor Paterson announced his proposed budget which includes a reduction in state aid to school districts. Mr. Grackin presented an analysis of the current year's state aid to Mr. Paterson's proposal. Extensive discussion followed which segued into a discussion on the budget target number for 2010-2011. Mr. Grackin asked the Board to decide upon a target rate increase so he would be able to present the first budget draft on March 1<sup>st</sup>. Discussion followed. The Board agreed upon a target 2 percent tax rate increase.

### Point of Sale Lunch Purchasing System at Huntington High School

Mrs. Rogan explained this is a system that would be used in the School Lunch Program. Mrs. Rogan explained the benefits of the program to both students and staff. Discussion followed. The Board decided this would be something to be considered in the future.
